Chase County Commissioner Meeting April 12, 2022

The Chase County Commissioner Meeting was called to order at 8:00 a.m. on Tuesday, April 12, 2022. Present were commissioners Jacci Brown, Duane Dinnel, Dennis Kunnemann, county clerk Debra Clark, county attorney Arlan Wine, and county highway superintendent Toney Krajewski.

Notice of the meeting was advertised in the Imperial Republican. An agenda was kept current and available in the office of the county clerk. The agenda and open meeting act are posted.

Papers received from Baker & Associates concerning the road project with Werner were signed by the chairman.

Duane Dreiling joined the meeting during open forum. He provided a handout entitled "Fuels and Fire Behavior Advisory Central Kansas and Nebraska" effective April 11, 2022 for 14 days. A request was made to have the purchase of an electronic smart board be put on a future agenda. Duane left the meeting.

Karen Baker joined the meeting concerning the juvenile services grant. Dennis Kunnemann moved to accept and approve the grant for juvenile services. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-yes; motion carried. The grant amount is \$91,568.00.

Jacci Brown moved to sign the community-based juvenile services aid grant sub-award. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried. This grant is \$10,686.00. The subgrantee is Family Skill Building.

Jacci Brown moved to approve Resolution 2022-13 approving \$4,000.00 funding to the criminal investigations account. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried. Karen Baker left the meeting.

RESOLUTION 2022 - 13

APPROVAL OF FUNDS FOR CRIMINAL INVESTIGATIONS ACCOUNT

WHEREAS, on November 24, 2020, the Chase County Attorney established a petty cash fund to use for criminal investigations with law enforcement or other special law enforcement expenses in Chase County;

WHEREAS, the County Attorney's Office's needs to have funds in the account to have the ability to issue checks, use a debit card and have authority for cash withdrawals from this petty cash account;

WHEREAS, the County Attorney's Office is requesting four thousand dollars (\$4,000.00) to be placed into the criminal investigation account in order to effectuate its purposes;

NOW, THEREFORE BE IT RESOLVED that this account shall be funded immediately with a four thousand dollars (\$4,000.00) deposit. A claim will be authorized for payment of the four thousand dollars (\$4,000.00) into the County Attorney's Office petty cash fund for criminal investigations.

Duane Dinnel moved to approve the March 22nd minutes. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-yes; motion carried.

At 8:25 a.m. Judge Patrick Heng joined the meeting to discuss funding for a full-time bailiff. The wage proposal was for a 35 hour week at \$17.00 an hour with insurance and retirement. The total expense was \$56,461.81 annually. Chase County share, based on the 2020 and 2021 case load, would be 8% or \$4,516.95. There will be an interlocal agreement drawn up. Wages paid and breakdown between counties would be revisited every two years.

Jacci Brown moved to approve funding for a bailiff. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

Judge informed the board that he had received the request for court appointed attorney for the Assessor on the TERC appeal. He had not made an appointment at this time. Judge left the meeting at 8:40 a.m.

Charlie Colton joined the meeting to inform the board of the Imperial Community Foundation Fund. Information was provided on community grants and scholarships provided through April 7, 2022 and the possible uses for the fund. Charlie left the meeting at 8:55 a.m.

At 9:00 a.m. the public hearing was opened to take testimony for or against the vacating of 20 feet right-of-way of all platted 80 feet wide streets in Champion and an additional 15 feet along the north side of Second Street between Mill Street and Kelly Street as recommended by the highway superintendent.

The board will also take testimony for or against the vacating of the alley running north and south through platted Block 5, Original Town of Champion, between Second and Third Streets.

Notice of the public hearings was advertised for three weeks. Notice was also mailed to owners of land abutting on or adjacent to the road to be vacated. Mailing was by certified mail with return receipt.

Gail Kealiher and Paul Nordyke were present for the hearing. Both own property in Champion. Discussion was held concerning the reason behind the request to vacate. Gail and Paul left the meeting.

The public hearings were closed at 9:15 a.m.

Dennis Kunnemann moved to approve Resolution 2022 – 14 to vacate the alley running north and south through platted Block 5, Original Town of Champion, between Second Street and Third Street, within Champion. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-yes; motion carried. The ownership will transfer to the adjoining landowners.

RESOLUTION 2022 - 14

VACATE NORTH-SOUTH ALLEY IN BLOCK 5 ORIGINAL TOWN OF CHAMPION

WHEREAS, an application to vacate the alley in Block 5 Original Town of Champion, between Second and Third Streets was submitted on November 8, 2021.

WHEREAS, the Chase County Board of Commissioners signed Resolution 2022-7 on February 8, 2022 directing the road superintendent to conduct a road study of the said alley and make a written report of said study.

WHEREAS, the road study was performed by Anthony (Toney) Krajewski, Chase County Highway Superintendent. The report shows that this alley running north and south through platted Block 5, Original Town of Champion, between Second Street and Third Street, within Champion, an unincorporated village in Chase County, Nebraska does not provide any community benefit. He feels it would better serve the public interest to vacate said alley and transfer ownership to the adjoining landowners.

WHEREAS, a public hearing was held on Tuesday, April 12, 2022 at 9:00 a.m. in the commissioner meeting room at the Chase County Courthouse. The purpose of the public hearing was to take testimony for or against the vacating of the alley and transferring ownership to the adjoining landowners. Notice of public hearing was advertised for three weeks. Notice was also mailed to owners of land abutting on or adjacent to the road to be vacated.

NOW THEREFORE, no objections being raised, the Chase County Commissioners hereby vacate the alley running north and south through platted Block 5, Original Town of Champion, between Second Street and Third Street, within Champion, an unincorporated village in Chase County, Nebraska. Ownership will transfer to the adjoining landowners as recommended by the acting highway superintendent, Anthony Krajewski.

RESOLUTION 2022 - 15

VACATE PART OF ROAD RIGHT OF WAY FROM PLOTTED STREETS IN CHAMPION

WHEREAS, a public hearing was held in 2016 to vacate a portion of the street right of way in Champion, Nebraska. There having been no resolution following the meeting the Chase County Commissioners signed Resolution 2022-6 on February 8, 2022 directing the road superintendent to conduct a road study of the platted 80 feet total width of street right-of-way in Champion, an unincorporated village in Chase County, Nebraska. The board feels the width is excessive and unusually wide and beyond the anticipated needs of the County for public use. The road superintendent was asked to make a written report of said study.

WHEREAS, the road study was performed by Anthony (Toney) Krajewski, Chase County Highway Superintendent. The report shows that a 60-foot right-of-way is sufficient to accommodate the community's, as well as the county's, needs and that the excess 20 feet be vacated and transferred to the adjoining landowners. He also recommends that an additional

15 feet of right-of-way be vacated along the north side of Second Street between Mill Street and Kelly Street to clear up some zoning issues and facilitate a clear title to the Teply property.

WHEREAS, a public hearing was held on Tuesday, April 12, 2022 at 9:00 a.m. in the commissioner meeting room at the Chase County Courthouse. The purpose of the public hearing was to take testimony for or against the vacating of the street right-of-way as recommended by the County Highway Superintendent and transferring ownership to the adjoining landowners. Notice of public hearing was advertised for three weeks. Notice was also mailed to owners of land abutting on or adjacent to the roads to be vacated.

NOW THEREFORE, no objections being raised, the Chase County Commissioners hereby vacate 20 feet of all platted 80 feet wide streets in Champion and transfer 10 feet on each side of the road to the adjoining landowners. An additional 15 feet of right-of-way shall be vacated along the north side of Second Street between Mill Street and Kelly Street and be transferred to the adjoining landowners as recommended by the acting highway superintendent, Anthony Krajewski.

Jacci Brown moved to increase the yard mowing payment to \$900.00 a month. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.
