Chase County Commissioner Meeting August 9, 2022

The meeting of the Chase County Commissioners was called to order at 8:00 a.m. on Tuesday, August 9, 2022. Present were commissioners Jacci Brown, Duane Dinnel, Dennis Kunnemann, clerk Debra Clark, and attorney Arlan Wine.

Notice of the meeting had been advertised In the Imperial Republican. The agenda was kept current and available in the office of the clerk. The agenda and open meeting act are posted.

Scott Bussell was present for open forum. He questioned the board about the minimum width of a county road and the percentage of grade. The berms are also a concern, as they do not allow you to get over. Discussion followed. Scott left the meeting at 8:15 a.m.

Abby Cyboron, Hospital Administrator was also present for open forum. She indicated she had read that the auditor had suggested the county discontinue the levy for the hospital sinking. Discussion followed.

Amy Rozelle joined the meeting to discuss the road secretarial position she has been offered. She wanted to address the wages. Discussion followed. Duane moved to offer a starting wage of \$18.00 per hour and full benefits with a minimum increase of fifty cents after 90 days, subject to review. Jacci Brown seconded. Duane-yes; Jacci-yes; Dennis-yes; motion carried. Amy agreed to respond within the week. Amy left the meeting.

A letter of resignation from the hospital board of trustees was received from Kim Kunnemann. The board accepted the resignation. An ad will be run in the newspaper for the position. Interested parties should contact their county commissioner.

Prairie Plains CASA had sent a letter requesting funding of \$4000.00. The request was reviewed. Discussion held. No action was taken.

At 9:00 a.m. bids were opened on the surplus pickups. Bids for the 2001 Ford F150 were: Edward Kohl-\$1000.00; William Pump-\$2,500.00; Daniel Mullanix-\$1351.00. Jacci Brown moved to accept the \$2500.00 bid from William Pump. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

Bids for the 1999 Ford F250 were: Derick Denman-\$1368.00; Bill Bischoff-\$1375.00; William Pump-\$3000.00; Ryan Greene-\$3767.00. Dennis Kunnemann moved to accept the \$3767.00 bid from Ryan Greene. Jacci Brown seconded. Dennis-yes; Jacci-yes; Duane-yes; motion carried.

Duane Dinnel moved to approve the minutes of the July 26th meeting. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-abstained as she was not present for the entire meeting.

Duane Dinnel moved to accept & sign change order #1 for an additional ¾ mile of paving on 346 & 734 road project. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-yes; motion carried. The additional paving cost is \$336,778.00.

Brad Foote has requested permission to place millings on 749 Rd from the east end of the concrete to past the east entrance 300 or 400 yards. He will pay all cost and future maintenance. Arlan was instructed to draw up an agreement.

Duane provided information on Wauneta Crossroads, LLC fall/winter propane contracts. Discussion followed. Decided not to contract but will look into programmable thermostats for the shops.

Dennis Kunnemann moved to approve the barrow material lease with Venango Farms, LLC for gravel, mag and dirt. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-yes; motion carried.

Meeting was recessed for a Board of Equalization meeting at 9:30 a.m. The meeting reconvened at 9:45 a.m. with all members present.

IT Security issue was continued from the last meeting. Terri State and Tori Otzel are present. Jacci Brown moved to accept the quote from Applied Connective. Dennis Kunnemann seconded. Jacci-yes; Dennis-yes; Duane-yes; motion carried. The initial setup fee is \$2125.00 and a monthly management service fee of \$382.50. These are to be budgeted to the General Fund-Miscellaneous.

A phone call was made to auditor Don Wilson concerning his findings during the audit. His audit of the Imperial EMS was discussed. If they get their own EIN# he won't look at that next year. If they do not, there would be an additional charge to include that audit. The auditor suggests the volunteers become part-time employees January 2023.

The board plans to meet with Imperial EMS president Craig Loeffler at 8:30 a.m. on the next meeting date of August 23rd. They may file a response to the auditor findings after that meeting.

Jacci Brown moved to sign the management representation letter to Donald D. Wilson. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

Tori Otzel reviewed the Credit Management proposal with the board. Abby Cyboron explained how that worked at the hospital. Jacci Brown moved to used credit management for collection of delinquent ambulance accounts. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

July 23rd at 3:00 p.m. was scheduled for a budget workshop. All officials are welcome to attend.

Abby Cyboron left the meeting.

The commissioners, clerk, county attorney and road secretary took a trip to Champion. They left in the transit at 11:00 a.m. The Teply property and the bridge were visited. The group returned at 12:25 p.m.

Tori is to call for locates on fiber, etc. at the bridge. The board felt the north end needed to be lowered to create a more gradual incline.

Arlan was asked to draw up paper work for an exchange of property. Putting a hydrant next to the well was discussed. The county will deed over the well and grant an easement to the garage entrance in exchange for the property now owned by Teply across the road to the north west.

Dennis Kunnemann moved to approve payment of claims as submitted. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-yes; motion carried.
