Chase County Commissioners February 13, 2024

The regular meeting of the Chase County Commissioners was called to order by Chairman Jacci Brown at 8:00am on Tuesday, February 13, 2024 in the Commissioner Meeting Room at the Chase County Courthouse. The open meeting act and agenda were posted. Meeting had been advertised in the Imperial Republican and on the county website. Also in attendance were Commissioners Billie Muehlenkamp and Kurt Bernhardt, County Clerk Wendy Moe, Highway Superintendent Tony Krajewski, Assistant Highway Superintendent Dick DeWester, County Attorney Joel Burke, Road Secretary Jeni Lotspeich, County Court Clerk Magistrate Karen Mueller and Greg Dannatt.

Karen Mueller was present for agenda item of Courtroom Upgrades. Karen provided information and options for new chairs or bench seating for the gallery seating area. Commissioners viewed photos provided by Karen and said they would discuss it and let her know how to proceed. Karen left the meeting.

Greg Dannatt was present for the agenda item of 335 Avenue Improvements. Greg has purchased land on 335 Ave north of the highway 6 intersection to eventually build a house. This road is open and maintained but not all the way to Greg's property. In order for a building permit to be issued for a house the road will need to be extended an additional 400 feet to meet the southern edge of his property. Greg will then maintain the road further beyond that access point as needed. Commissioners do not believe this will be a burdensome road to open and maintain as it is on a section line, already open part of the way and only needs to be extended an additional 400 feet. Commissioners directed clerk to schedule a Public Hearing for this matter at the February 27 Commissioner Meeting to be heard at 9:30am. Greg left the meeting.

Highway Superintendents were present for open forum to present tentative plans for the One- and Six-Year Road Plan. Discussion of the Dump Road Extension project and Onyxx overlay on Old Highway 6 commenced. Tony suggested using Highway Buyback funds to cover the cost of the Old 6 project. Commissioners instructed Tony to prepare bid specs for the Dump Road Extension project. Tony left the meeting.

Assistant Highway Superintendent Dick DeWester stayed to review road classifications with commissioners and consider possibly reclassifying some of the unimproved roads he has identified. Dick has identified approximately 105 miles of county roads that are currently unimproved and may be reclassified as minimum maintenance. Dick would like to update a handful of these roads annually until all have been addressed and reclassified as needed.

Specific roads identified at this time were 745 Road and 321 Ave extending three miles west of 321; 746 Road and 321 Ave extending three miles west of 321; 320 Ave and 736 Road extending two miles south; 323 Ave and 736 Road extending north two miles; 740 Road and 326 Ave extending east one mile; 727 Road and 344 Avenue extending north one mile and 738 Road and 345 Ave extending two miles south. Dick left the meeting.

Commissioner Brown recessed the meeting at 9:00 for Board of Equalization. Meeting reconvened at 9:43.

Commissioner Muehlenkamp moved to approve the minutes from the January 23, 2024 meeting. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

County Road Policy was reviewed, commissioners requested that mowing rates be added to the policy, wording around road damage section be modified to identify "commercial business, farmer or individuals" and to add "If trees and shrubs located on private property create obstruction it shall be the responsibility of the owner to remove and take care of the obstruction at owners' expense". Commissioner Brown moved to approve the policy as amended. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp — yes; Brown — yes; Bernhardt — yes. Motion carried. Complete policy will be made available on the Road Department portion of the County website.

Courtroom upgrades were discussed. Commissioner Brown informed other board members that additional window coverings are needed for the windows behind the jury box as the

current blinds aren't dark enough and sunlight coming through causes a glare on the television. Commissioners discussed options and decided to look into some type of tinting that will adhere directly to the window behind the shades to remedy the problem. Seating options presented by Karen were basic padded chairs for approximately \$8,000, benches/pews for approximately \$10,000 or Super Chairs for approximately \$15-20,000. Commissioners agreed that they would prefer chairs rather than bench or pew style seating for the courtroom gallery. Commissioner Brown will contact Karen Mueller and instruct her to gather further information for the chair seating options to be presented to the board.

Commissioner Brown moved to approve claims as presented. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.
