Wages for the Tori Otzel were discussed. Because there is no longer any part-time help Dennis Kunnemann moved to increase her wages from \$18.03 an hour to \$20.00 an hour. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-yes; motion carried.

The board requested a meeting with the Veteran's Service Committee be scheduled for 9:00 on January 25, 2022. The clerk will make the notification.

Salary discussion for elected officials for 2023 thru 2026 was continued from the last meeting. The board determined the figures they wished to place in the resolution. The 2023 salary for Assessor, Clerk, Treasurer and County Attorney will be \$66,000 with a 3% increase each year.

The Sheriff will be paid 125% of the \$66,000 base salary with an additional \$7,000 for administration of dispatch and jail for a total of \$89,500 in 2023. His salary will also increase 3% each year. The salary for sheriff and communications were combined as one salary for 2023-2026.

The surveyor position will pay 50% of the clerk, treasurer, assessor and attorney salary.

The Nebraska Constitution allows an increase or decrease at the beginning of the full term of any member. Therefore, the board elected to set a salary for only two years for the commissioners. They set 2023 at \$30,000 and 2024 at \$30,900. The 2025 and 2026 salary will be established by resolution in two years.

The board recessed at 12:10 pm. The clerk will draw up the salary resolution and make the deposit for the payment of claims. The board will reconvene at 1:30 p.m.

The board reconvened at 1:30 p.m. Dennis Kunnemann moved to approve Resolution #2022-04. Jacci Brown seconded. Dennis-yes; Jacci-yes; Duane-yes; motion carried.

County Commissioner salary is being set for two years as allowed by the Nebraska Constitution. Their salary may be increased or diminished at the beginning of the full term of any member. The salary for 2025 and 2026 will be established by Resolution in two years.

BE IT FURTHER RESOLVED that in addition to the above stated salary the elected official shall receive during his or her term of office, at county expense, single health and dental coverage. Should health insurance no longer be offered by the county, the Elected official shall receive a subsidy, equivalent to the last year's premium, toward the cost of single health insurance in the open market. Such additional funds shall not be considered part of the official's salary. Should an official elect the Cash-In Lieu option, it shall not be considered part of the official's salary either.

The County Sheriff salary as stated above includes management of the communications center and jail.

The County Attorney salary as stated above shall include Child Support Enforcement duties.

Officials may receive Christmas gift certificates, as other employees. Such gifts shall not be considered part of the official's salary.

The County reserves the right to enter into an agreement with any qualified elected official as the budget-making authority. It is the intent of the Chase County Board that such agreement shall not constitute an increase in the herein adopted salary.
