Chase County Commissioners January 9, 2024

The organizational meeting of the Chase County Commissioners was called to order by County Clerk Wendy Moe at 8:00am on Tuesday, January 9, 2024 in the commissioner meeting room of the Chase County Courthouse. Also, present were Commissioners Billie Muehlenkamp and Kurt Bernhardt. The open meetings act and agenda were posted. The meeting had been advertised in the Imperial Republican.

Clerk called for nominations for Chairman of the Board. Commissioner Bernhardt nominated Commissioner Brown as chairman for 2024. Motion seconded by Commissioner Muehlenkamp. With no further nominations, nominations ceased. Muehlenkamp — yes; Brown — absent; Bernhardt — yes. Motion carried. Commissioner Brown to serve as Chair for 2024.

Commissioner Brown joined the meeting. Clerk turned the meeting over to Chairman Brown.

Chairman called for nominations for Vice Chair. Commissioner Brown nominated Commissioner
Bernhardt to serve as Vice Chair for 2024. Motion seconded by Commissioner Muehlenkamp.

Muehlenkamp – yes; Brown – yes; Bernhardt – abstain. Motion carried.

County Attorney Joel Burke joined the meeting for the agenda item of Lee's Trees. After reviewing the agreement between Perkins and Chase counties pertaining to the maintenance of that portion of the road, County Attorney agrees with decision made at previous meeting, the county will have the trees on the south side of the road removed.

Rex Felker joined the meeting for open forum. He wanted to inquire about priority routes for snow removal. His main concern was Old Highway 6 as he indicated that it was not cleared immediately after the recent snow storms. Commissioners assured him that Old 6 is a priority route for snow removal. Rex left the meeting.

Assistant Highway Superintendent Dick DeWester was present to discuss fuel tank bids with the board. Dick got informal bids from Mittens Inc in Oakley, KS and Orthman Energy LLC, Lexington, NE for 6,000- and 10,000-gallon fuel storage tanks to be placed at the Lamar Shop. After review of bids, Commissioner Bernhardt moved to accept the bid from Mittens Inc for an 8' x 16' (6,000 gal) UL 142 Specs Double Wall Steel Storage Tank for \$26,358.81. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Duane Dreiling joined the meeting. Commissioner Brown moved to appoint Duane Dreiling as Chase County Emergency Manager for the year 2024. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Emergency Manager Dreiling here to discuss agenda item of Generator. The Generator at the courthouse has not been working correctly, Duane would like to advertise for formal bids to replace the generator and would like for the new generator to include a service agreement. Commissioners instructed him to put together bid specs and have them ready for approval by the January 23 meeting.

Veterans Service Office Duane Todd joined the meeting for signing of MOU for Nebraska Department of Veterans Affairs. This is the user agreement for software that he uses to assist Veterans, it gets renewed every two years. Commissioner Bernhardt moved to approve the signing of the MOU between the Nebraska Department of Veterans Affairs and Chase County to extend the original agreement for an additional two years. Motion seconded by Commissioner Muehlenkamp.

Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. Chairman signed agreement.

Scott Way and Ryan Stromberger joined the meeting for unfinished business item of Fair and Expo Building Rental Agreement. Rental rates were discussed. Per the agreement that users will sign, full weekend rental (Fri thru Sun) will be \$1000 with a \$500 damage deposit. Day use rate will be \$200 per day. Renters of the facility will come to the courthouse road office to sign the agreement, pay rental fees and damage deposit, obtain (or show proof of) liability insurance and get the key from the road secretary. The question of who the key will be returned to and who will be responsible for inspecting the building to determine if deposit should be returned was addressed. Ryan doesn't think this arrangement is ideal but agrees that we need policy and a consistent process in place. Both parties agree to try it this way for a while and will revisit the issue and make changes to the process later on if necessary.

Commissioner Brown indicated that there seems to be some misunderstanding as far as ownership of buildings and responsibility over the Fair Grounds as well as the budget and funding of Fair Ground maintenance and upkeep, among other things. She asked if it would be beneficial to have a joint meeting between the Commissioners and Fair Board to clarify these points. Ryan and Scott indicated that a joint meeting would be a good idea. Commissioners instructed Clerk to advertise for a Joint Meeting. Commissioners will join Fair Board's regular meeting on January 18 at 6:30pm.

Commissioner Bernhardt moved to approve Resolution 2024-1 for the Designation of Publication of Legal Notices. Motion seconded by Commissioner Brown. Muehlenkamp - yes; Brown - yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is available in the office of the county

Commissioner Brown moved to approve Resolution 2024-2 to Authorize Treasurer to Invest Monies. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is available in the office of the county

Commissioner Muehlenkamp moved to approve Resolution 2024-3 to Designate Depositories, set payroll schedule, proceedings of tax certificates, etc. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is available in the office of the county clerk.

Commissioner Brown moved to appoint Anthony Krajewski, Class A License S-1021, as the County Highway Superintendent for 2024. Motion seconded by Commissioner Bernhardt. Muehlenkamp yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to appoint Richard DeWester, Class B License A-1761, as the Assistant Highway Superintendent for 2024. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

After discussion of outside board assignments Commissioner Brown moved to appoint Billie Muehlenkamp as the representative to Region II Human Services, Region II Behavioral Health and West Central Nebraska Area Agency on Aging boards; Jacci Brown as representative to Southwest Nebraska Public Health, West Central Nebraska Developmental, Champion Mill and Chase County Safety boards; and Kurt Bernhardt as representative to the Chase County Community Hospital and Southwest Nebraska Juvenile Services boards. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to approve Resolution 2024-4 setting Commissioners salary for 2025-2026, returning the salary amount to 50% of elected officials salary. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is available in the office of the county clerk.

Commissioner Bernhardt moved to approve claims as submitted. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to approve the minutes of the December 28, 2023 minutes as written. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Agenda item of Ambulance Telehealth was addressed. Commissioner Brown called Craig Loeffler so the board could get clarification from him. Craig indicated that this is a telehealth system that will be installed in the back of ambulances so EMT's have a help line available during transport and transfers. The line will provide 24/7/365 professional medical counseling and consulting services for EMS Ambulance Service Agencies. The equipment, installation and access fees will be covered by State Grant funds for the first year, the State will pay directly, it is not a reimbursement grant. Craig indicated it is likely that grant funds may cover a portion of additional years, if not, services can be cancelled or the EMS service or county may opt to pay fees on their own. Commissioner Muehlenkamp moved to accept the one-year EMS Telemedicine Services Agreement for Imperial EMS. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to approve the semi-annual Community Development Betterment Grant Program Income Report. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to appoint Preston Smith to fill one of the vacant District #3 Fair Board positions for a 3-year term to expire December 2026. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to appoint Clay Owens to fill the second vacant District #3 Fair Board position for a 2-year term to expire December 2025. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

With no further business to come before the board, Chairman Brown adjourned the meeting at 11:12am
